Oral Mention

Dr. Jayashree Laha : Pointed out for conducting the practical examinations of Lab-based subjects in undergraduate level in the respective colleges. The Hon'ble Vice-Chancellor of Vidyasagar University suggested to write a letter to the Controller of Examinations of this University in this regard.

Dr. Jayashree Laha : Pointed out the traffic jam frequently in front of the FCI Godown towards the road of the main gate No. 2 of the Vidyasagar University. The Hon'ble Vice-Chancellor of Vidyasagar University suggested that the University will send the letter to the local administration including the District Magistrate, the Superintendent of Police and others of Paschim Medinipur District in this regard.

Dr. Asim Kumar Bera : Suggested for re-structuring the Undergraduate Regulations of Vidyasagar University. The Hon'ble Vice-Chancellor of this University suggested that Dr. Bera be requested to submit a letter pertaining to change/re-structure of U.G. Regulations of Vidyasagar University to the University for further action in this regard.

Confirmation: 01. To confirm the draft resolutions of the First meeting of the Eighth Executive Council of Vidyasagar University held on 23.06.2016.

Resolution: Resolved that the draft resolutions of the First meeting of the Eighth Executive Council of Vidyasagar University held on 23.06.2016 be read and confirmed with minor modifications & corrections.

Deferred Item: 02(a) To note the letter dated 10.06.2016 jointly submitted by the President and the Secretary, WBCUPA, Vidyasagar University Unit pertaining to implementation of some decisions taken by the WBCUPA, Vidyasagar University Unit in its meeting dated 01.06.2016.

Resolution: The Executive Council of the Vidyasagar University noted the letter dated 10.06.2016 jointly submitted by the President and the Secretary, WBCUPA stating that the WBCUPA, V.U. Unit in its meeting dated 01.06.2016 took some decisions pertaining to early implementation of (a) re-consideration the decision of EC taken earlier regarding employment in other academic institutions, (b) filling up the vacant positions of faculty of this University and their placement/promotion under CAS, (c) financial support for holding special lecture series by eminent faculties from different institutions and (d) appointment of full-time Deans of this University.

After thorough discussion on the letter of WBCUPA, Vidyasagar University Unit pertaining to implementation of some decisions taken by the WBCUPA, Vidyasagar University Unit in its meeting dated 01.06.2016, it was resolved that appropriate steps in respect of employment in other academic institutions as decided by EC earlier, be taken up on a case to case basis. Resolved also that other points of the aforesaid letter regarding filling up the vacant positions of faculty of this University and their placement/promotion under CAS, financial support for holding special lecture series by eminent faculties from different institutions and appointment of full-time Deans of this University, raised by them, are irrelevant as necessary actions have already been taken up by the University in this regard.

02(b) To place before the Executive Council of Vidyasagar University, the letter bearing No. MAC/NOC(WBSCH)/667/16 dated 21.03.2016 submitted by the Principal, Midnapore Art College, Midnapore pertaining to submission of No Objection Certificate from the West Bengal State Council of Higher Education regarding transferring affiliation of Midnapore Art College from Rabindra Bharati University to Vidyasagar University.



Resolution: The Executive Council of the Vidyasagar University noted the letter bearing No. MAC/NOC(WBSCH)/667/16 dated 21.03.2016 submitted by the Principal, Midnapore Art College, Midnapore pertaining to submission of No Objection Certificate from the West Bengal State Council of Higher Education regarding transferring affiliation of Midnapore Art College from Rabindra Bharati University to Vidyasagar University. The Executive Council also noted the No Objection Certificate of the West Bengal State Council of Higher Education submitted by the Principal in this regard.

After thorough discussion on the letter submitted by the Principal, Midnapore Art College, Midnapore pertaining to submission of No Objection Certificate from the West Bengal State Council of Higher Education regarding transferring affiliation of Midnapore Art College from Rabindra Bharati University to Vidyasagar University, it was resolved that the prayer regarding transferring affiliation of Midnapore Art College from Rabindra Bharati University to Vidyasagar University be declined as there is no such provision to offer such programme in this University at present.

- 02(c) To consider the letter dated 18.04.04.2016 submitted by CA Ananda Moy Sarkar, Finance Officer (Actg.) of this University pertaining to enhancement of the consolidated pay per month with effect from the date of joining the post of Finance Officer (Actg.), i.e. from 01.02.2016.

Resolution: The Executive Council of the Vidyasagar University noted the letter dated 18.04.04.2016 submitted by CA Ananda Moy Sarkar, Finance Officer (Actg.) of this University praying for implementation of the enhanced pay with effect from his date of joining the post, i.e. from 01.02.2016. The Executive Council also noted that the Seventh Executive Council of Vidyasagar University in its earlier meeting on the basis of prayer of CA Aanda Moy Sarkar regarding enhancement of his consolidated pay per month as Finance Officer (Actg.) enhanced his said pay to Rs.60,000/- (Rupees sixty thousand) only per month with effect from 01.04.2016.

After careful consideration of the letter submitted by CA Ananda Moy Sarkar, Finance Officer (Actg.) of this University pertaining to enhancement of the consolidated pay per month with effect from the date of joining the post of Finance Officer (Actg.), i.e. from 01.02.2016, it was resolved that the consolidated pay of Shri Sarkar as Finance Officer (Actg.) be enhanced by Rs.5,000/- (Rupees five thousand) only per month in addition to his existing consolidated pay of Rs.60,000/- (Rupees sixty thousand) only per month. Resolved also that his enhanced pay be effective from his date of joining the post, i.e. from 01.02.2016. It was resolved further that the matter be forwarded to the Finance Committee of the University for noting. Resolved again that no further request for enhancement in this regard will be entertained by the University in future.

- 02(d) To consider the letter dated 10.05.2016 submitted by Shri Ashimava Praharaj, Accounts Officer of this University pertaining to permission for continuing his Ph.D. work at the Vidyasagar University.

Resolution: The Executive Council of the Vidyasagar University noted the letter dated 10.05.2016 submitted by Shri Ashimava Praharaj, Accounts Officer of this University stating that before his joining at the Vidyasagar University as Accounts Officer, his pre-registration seminar and course work of his Ph.D. work was completed. After joining this University he applied for continuing his said Ph.D. work but the University authority did not permit him the same.





Now he wants to complete his unfinished Ph.D. work at the Vidyasagar University without hampering his normal duty at this University. In this connection Shri Praharaaj has requested to the University for allowing him to continue the said Ph.D. work at V.U.

After careful consideration of the letter of Shri Ashimava Praharaaj, Accounts Officer of this University pertaining to permission for continuing his Ph.D. work at the Vidyasagar University, it was resolved that Shri Praharaaj be encouraged to pursue the said Ph.D. programme in any other University except Vidyasagar University. Resolved also that the relevant documents regarding his Ph.D. programme may be forwarded to the concerned University in which Shri Praharaaj desires to pursue the said programme, if it is required by the incumbent concerned. Resolved further that the leave may be considered for this purpose, if it is needed by Shri Praharaaj.

- 02(e) To place before the Executive Council of Vidyasagar University, the Note dated 20.06.2016 prepared by the office of the Registrar pertaining to conversion of some reserved teaching and non-teaching posts of Vidyasagar University to general category.

Resolution: The Executive Council of the Vidyasagar University noted the note dated 20.06.2016 prepared by the office of the Registrar of this University stating that the Assistant Commissioner of Reservation, Backward Classes and Welfare Department, Government of West Bengal was sent a letter pertaining to conversion of some reserved teaching and non-teaching posts of Vidyasagar University to general category. The Executive Council also noted that in the said letter it was also stated that if we do not receive any communication from their end in this regard within one month we will place the matter before our appropriate authority for further process. The Executive Council noted further that although three months have already been over from the date of issue of the letter, we have not received any communication from their end in this regard till date.

After thorough discussion on the note prepared by the office of the Registrar pertaining to conversion of some reserved teaching and non-teaching posts of Vidyasagar University to general category, it was resolved that the said matter be pursued with the Backward Class and Welfare Department, Government of West Bengal again in this regard.

**Resolution :** *The Executive Council of Vidyasagar University noted the letter bearing No. EIILM/DO/VU/VCO/2016 dated 10.06.2016 submitted by the Director, Eastern Institute for Integrated Learning in Management (EIILM), Kolkata stating that a large number of students appearing CAT and MAT in West Bengal are moving out of the State to study professional course like MBA in Southern, Western and NCR and getting easy access to admission in different universities with graduation marks much below the cut off marks in our State. Many of our universities are known for awarding lesser marks to students who would fetch much higher marks in many universities outside the State. A 40% scorer of standard university of West Bengal is by and large, equivalent to above 50-55% scorer of many university located surrounding West Bengal. In view of the above, the Director has requested to reduce the marks criteria by 5%, i.e. for general candidates from 45% to 40% and SC, ST & Minority candidates from 40% to 35% marks scored by the candidates in graduation. After thorough discussion on the letter submitted by the Director, Eastern Institute for Integrated Learning in Management (EIILM), Kolkata pertaining to reviewing the marks criteria for admission to the regular MBA Course of Vidyasagar University, it was resolved that the revised minimum qualification for such course will be graduate with 40% of marks. However, such cases which are below 45% marks have to be dealt with on a case to case basis on receipt of request from the concerned institute.*

- 06(b) To consider the letter dated 09.07.2016 submitted by the Teacher-in-Charge, Y.S. Palpara Mahavidyalaya pertaining to enhancement of the intake capacity for the first year course of the Department of English of the said college.

UGC has taken a serious view of the issue and will be constrained to take punitive actions as are notified in Regulation 9 of UGC (Grievance Redressal) Regulations, 2012 against the University. In this connection, the Secretary has requested once again the University to religiously follow the UGC Regulations, 2008 and facilitate smooth and timely entry of our students in the world of possibilities and promises.

After thorough discussion on the letter received from the Secretary, University Grants Commission, New Delhi pertaining to follow the UGC Regulations, 2008 regarding awarding of Degrees in time to the students enrolled in different programmes of study offered by the University, it was resolved that the said regulations of UGC be followed in this University for this purpose. 


